 - II. Legislative Capital Outlay-

- a) We were awarded \$10,000.00 C O funds. People are being awarded dollar amounts, and the amount is not being used, so LCO is being careful about this problem. If anyone can attend the Wed., May 12 meeting in Santa Fe, they should contact Joe Z.
- b) In mid-July we will plan for a public meeting before entering into an agreement with El Valle. ECMDWCA will be the fiscal agent. Balancethrough an appropriation we will be getting from NM Environmental Dept.
- c) We are feeling more positive about the Water Trust Board- They give good feedback if something is missing.
- d) DFA review is of concern.
- III. Bureau of Reclamation nothing to report.

IV. USDA -Plans to apply -

- a) Have applied and are awaiting response. We put in a bid, proposing a plan of similar scope (\$350,000 45% grant and 55% loan).
- b) More people need to connect. If USDA accepts the application, they will provide a listing of what we must do.

V. Drinking Water State Revolving Fund

a) 100% loan, with a potential of 25% forgiven. We are a higher priority due to the Water Trust Bd. Agreement. Environmental Protection Agency provides funds to the states

- c. Water emergency updates
 - I. New Reports Gene has not heard anything recently.

 - (a) If anyone is having trouble with his well, see if there is an issue.
 - (b) Public meeting. Joe will map the problem. To get an understanding of the magnitude of the problem and so people will be aware of our organization and what we are trying to do.

d. Water hauling

 - (a) Matt Reynolds is the new driver
 - (b) Safety first is considered in all issues
