- 5. Treasurer's Report.
 - a. Filings status (DFA Budget)
 - 1) Crystal reported that at present (10/10/13), the balance is \$12,968.22 combined Checking and Savings. \$1,300.00 was deposited- combination of three assessments and 11 water delivery payments. 2) there is no lapse in work comp insurance. We are now covered under Mountain States Insurance Group.
 - 2) Assessments Report- a) DFA Quarterly report for the truck loan is current, Water Trust Board Report is current. b) 990N Report is complete c) Annual Assessment. Crystal reported that she does not have a clear count of how many assessments have been paid and that she is in need of the list of membership in order to track this item accurately. In addition, she reported that there are still some outstanding assessments from last year.

 - a) Review of current and planned funding applications
 - i) Water Trust Board Legislative Capital The Water Trust Board should be closing out invoicing and will then be on an annual \$10,000.00 loan over a twenty-year period at the rate of \$500.00/yr. Current funding for the Water Trust System...some has been submitted, budget, etc, due Oct 1,2013.

Ii,iii,iv,v)) Legislative Capital Outlay / BOR/USDA Application Status/Funding Workshop Report...

Joe reported that verification of our match is pending, and he will send for a waiver of current match funding given our status as a startup organization...leverage applies. We will hold off on submitting project description There is a need for proper wording re: DFA measurements, etc. for \$10,000. We still have it. **Iii-** no action re: **BOR iv) USDA Application Status-**Joe received a letter from USDA informing him of items yet to be clarified. Government status (at present) is holding things up. **v) Funding Workship Report....**Basically, the group is putting in

another application to extend for over \$700,000.00...- for design/construction in the 2014 application. Joe attended a workshop re: funding application procedures. He reported that his year, the procedure was not bad, but 2015 will be more complex. We will continue to work for continuation of the funding- pressing forward.

- **b) Ell Valle MOA** Joe reported that there is slow, but steady progress on this issue. He needs someone to attest- membership agreement with the Ell Valle Alliance. We will need a coverplate saying that we are signing on with El Valle for regional collaboration.
- c) Water emergency update..Gene reported that there were no new emergencies reported.

 - ii) Crystal reported a disbursement of \$435.00 for a water hauling pump.
