5 Treasurer's Report

- a Crystal was not in attendance.
- b El Valle contract: Ramon will rewrite the contract indicating that we won't pay them until the system is operational, but we will continue paying for the water hauling services.
- c CPA-IRS Issues: Dennis, Gene and Ramon will be meeting with a CPA in Albuquerque next week who has expertise with our situation. Ramon has contacted the State Auditor's Office to obtain a letter stating what date we became a government agency.

6 Water System Phase I Update

- a Legal updates. Ken hasn't heard anything about the status of our water rights transfer, nor received official notice that the city dropped their protest.
- b Corn litigation Ken filed an answer to the amended complaint, and a motion to dismiss the paragraph dealing with impairment of the aquifer.
- c Point of Diversion notices were published.
- d Meter issues
 - i Cheryl brought up the issue that technically 4 members should have paid for their meters, since they joined after the first funding application was submitted. There was some discussion that we need to start collecting the fee from members along the next phase as soon as we are notified of a funding award.

7 Funding

- a Water Trust Board 2018 Application
 - i Joe had proposed that we continue north on Mira Sol to connect 4 people, then go east along the county road to the base of the hill, connecting 5-8 people. Cheryl will contact people along the proposed route to try to get a few more members. There are some issues with the right of way to the gas station, and there are no longer any members in the Blue Ridge area. It was agreed that this was a good plan. Cheryl will see if Joe will work on the application.
 - ii Special meeting next Thursday, September 14 at 7:30 to approve the resolution to authorize the submission of the application to the WTB. We'll also have an update on the meeting with the CPA.
- b Motion made and seconded to approve amendment 4 to the Scope of Work for the PER for Souder Miller. (Cheryl/Gene) Motion passed.

 - a Our Application for Potable Water Hauling Operations was rejected because it was incomplete. Gene will discuss with Ramon.
