Meeting was called to order at 7:02 with a quorum in attendance.

- 1. Notices of meeting were posted and e-mailed
- 2. Motion made and seconded to approve the agenda. (Dennis/Crystal) Motion passed.
- 3. Motion made and seconded to approve the minutes from October 11th. (Dennis/Cheryl) Motion passed. Motion made and seconded to approve the minutes from October 18th. (Dennis/Cheryl) Motion passed.

4. Financial

- a. Treasurer's report: See attached
- b. Billing There might have been an error on the meter reading of George Vigil, so will continue to monitor. Everyone seems to be paying.
- c. 2019 budget There is a projected negative balance of \$845.84 so we need to find ways to save some money. Based on electric usage, it looks like there will be a significant savings from the budgeted amount
 - Motion made and seconded to approve the 2019 budget (Crystal/Dennis). Motion passed
- d. Crystal has asked to be taken off as treasurer. Liz Valenzuela has offered to take over. She, Crystal, Dennis and Jim will coordinate the transfer over the next two months.
 - i. Motion made and seconded (Dennis/Crystal) to nominate Liz Valenzuela for the board. Motion passed.

5. Corn Lawsuit

- a. Gene received a request for public records for the documents regarding the construction on Dorothy Road. Gene gave them to Chico.
- b. There is a hearing on November 19th, which Dennis will not be able to attend. It doesn't look like anyone else will be able to go. Gene should get maps from Chris Baca and Ken King to prove that Bourbon's property includes the road.

6. Water System

- a. Since we need to run water at each end of the system to flush it each month, it was proposed that we offer to sell it as non-potable water. Discussion followed as to the pros and cons, and we will table a decision until next month.
- b. Still have 7 connections.
- c. Sampling Plan
 - i. Cheryl will be meeting with Karen Tapias soon.
 - ii. She has been contacting homeowners to have them do lead sampling. .
 - iii. Probst and Ditmanson will not be connecting until spring, and they are both on the regular sampling schedule. Crystal and Chris Baca will do it.
 - iv. Lead testing Cheryl will contact the person at the drinking water bureau to confirm the sampling schedule, and to ask what happens if lead is tested positive.

- d. The Drinking Water Bureau said we are not in compliance because we needed to submit several water samples. Carlos took the required samples and they were all in compliance. They were submitted to the Drinking Water Bureau.
- e. A letter was submitted to Wayne Jeffs stating our plan to comply with the four issues sited in the Sanitary Survey. Gene has received the NSF hose, Cheryl has printed a log-book for the water hauling truck. We are still trying to get a recommendation from Carlos on the type of Colorimeter we need.
- f. Dennis investigated totalizing meters and found one on Amazon for \$40. He will order one and submit the paperwork to the OSE
- 7. The Capital Outlay questionnaire was submitted.
- 8. Water Trust Board Application Timeframe
 - a. Gene gave a presentation to the WTB on November 1st. They liked our idea of a public fill station. We should know by spring if we will received our funding.
- 9. Water Hauling-report and review
 - a. There have been no applications for the driver position. Since there is so few deliveries, it has not been a burden on Gene.
 - b. Cheryl will change the phone number on the website.

- a. Mitch asked about the news release. Cheryl suggested that we wait until the DWB formally approves it. Thank you notes need to be sent to all donors. Potable needs to be spelled correctly on the truck.
- b. Gene made an 11 x 17 "Another El Creston Water Customer" sign and had it laminated. It is visible from the road, so he will print out, laminate and mount 15 more.
