Participant updates and health concerns @ 0:00

The meeting began with participants providing updates on their health and personal situations. Gene discussed his recent hospital visits and the support he has received from neighbors. The group expressed concern for Gene's well-being and wished him continued recovery.

Financial report and reserves @ 4:45

The Secretary provided a detailed financial report, including the current checking account balance of \$10,452.53, loan reserve of \$12,500, capital reserve of \$12,800, and total unreserved cash of \$11,715.56. The group discussed the importance of maintaining these reserve funds for future needs.

Meter reading consistency concerns @ 15:07

The Secretary raised concerns about inconsistent meter reading dates leading to fluctuations in member bills. The group discussed potential solutions, including having members self-report readings or transitioning to a flat-rate billing structure. They agreed to follow up with the meter reader to ensure more consistent timing of readings.

We have the loan reserve for \$12,500, the capital reserve is set at on our maintenance reserve is \$12,800. So total unreserved is \$1,263.03.

Our overall total underserved cash balance is \$11,715.56. And we have a water connection stand by payment that we received.

We received \$2,669.22. So general received tax was \$163.60 and their payments were \$2,505.72.

here's what here is my question and I think this is the one that coordinates with the meter readers more than anybody else but when I got my bill and this was a couple months ago I've got a bill and it was the minimal which I haven't had a minimal bill in a couple years since I got my water softener and so I was really surprised I think it was from February that I got a bill for the minimal amount and then the next month I got a much larger bill than I expected and so my question is are we reading the meters on the same day each month and Liz had put a responded on that on an email she said that they're supposed to be collecting the reading readings within

five days of the 28th day of each month and so that's what they're supposed to be doing but the reason I

The reason I'm questioning that is the way we charge people is that there's a baseline and then you charge so much as you use more, you get charged more.

So as a base, I think it's 4,000 gallons and then the next 1,000 gallons is at some rate and then the next 1,000 is a little bit more and the increase is to train.

And if they read the meter three weeks apart one month and then five weeks apart, the next month, we're going to be getting these oddball things because the billing is based on a consistent reading time.

In an agreement and that's what if we do self reading? mean, you should read it yourself and then if you don't get a proper meter reading that you think is wrong, then you could, I guess, send your meter reading.

And that's the thing we need to make sure that the date is consistent. I think that's my main thing.

Or if the date's not going to be consistent, then we need to maybe make some adjustments to the rate schedule, so it's a more of a flat rate.

Because if you're just paying for the amount of water you use in one month, you're getting billed for five weeks.

And the next month, you're getting billed three weeks. Well, that's OK because I'm paying for the water I'm using.

But if I'm getting paid for basically penalized for extra water because they were five weeks apart, that's the piece that I want to make sure.

So I will coordinate with, I'll make sure that Liz understands that that's what we're talking about. And so when she's talking to them that we run, it'd be very, very clear that it

needs to be very close to the same day each month, because of the way our rate structure is.
