The water has been shut off, and the tenant would need to pay the full balance plus a reconnection fee to have service restored. They also discussed the absence of the board president, Conrad, who has not been attending meetings, and the need to potentially replace him.

### New acting president @ 39:00

The group agreed that the current acting president, Matt, would continue in that role until the next annual meeting in March, at which point a new president would be elected. They discussed the need to recruit additional board members from among the water system users to help govern the organization.

### Asset management plan @ 46:16

The group discussed the status of the asset management plan, which is being developed with the help of a grant. Once the plan is complete, it will provide better guidance on the appropriate level of maintenance and capital replacement reserves.

## Recap and next steps @ 52:29

The group reviewed upcoming tasks and deadlines, including obtaining documentation related to a past tank maintenance project. They scheduled the next board meeting for December 5th and adjourned the current meeting.

balance of 20,506. The water connection standby payments were from May of 23 through December 24. The revenues received were 2,77574.

The breakdown of the payments versus grocery receipts and we received three annual assessments payments from three property owners and one of them gave a \$25 donation.

One of the annual assessment owners notified me that they, well, Wendy, she said they decided not to support us this year.

So that's pretty Normal Yeah, I had budgeted for the assessments from last year to come in this year because in the past That's kind of when they rolled in but all of them came in last year So this budget about I actually put in January, but it'll probably get picked up in November and December as the remaining You know us seventy five dollars a year people Pay up so yeah, so that's some of that's come in since you put this together since you put it out last quarter Yeah

So again, no big deal, accounting is a timing difference from what I budgeted paying for the various quicken and stuff out of your budget and when it's actually going to get paid.

So it got paid, but I didn't budget it for later. Again, you know what we're talking about peanuts. The biggest, let's just skip to the biggest area, your operations and maintenance, that's the down payment, first half on the hybrid and that just wasn't budgeted.

so there's going to be another payment. The total is going to end up to be about just under \$48,000 according to the billings.

And so you'll be over budget on that, but that's, you know, that happens. major repair came in. it wasn't anticipated.

But you've got tons of money in your unrestricted reserves to cover it. So again, everything is very predictable in your basic operations.

Some things, as always, normal pop-up. The only biggie this time around that's worth even worrying about or talking about is the fire hydrant, which just couldn't have been anticipated.

But everything's covered. You've got plenty of money. So that's my short boring report.

dumping all our extra money in there, which is probably prudent, but maintaining an unreserved balance of roughly 20,000. So, short answer is yes, the reserves will go up next year.
