So I'm going to go line by line, but what I'm going to do is cover the differences between last budget and this year's actual, and then I'm going to explain how I came up with the budget for 2025, line by line, so you can kind of see how I went.

And I did send out the explanation documents, but I'll try to short circuit things here for you. So that's what I'm going to do, variances, negative numbers are bad, positive numbers are good.

So if you've got lower assessments, that's a negative number. If you've got higher expenses, that's a negative number, because that's kind of the way these variances are presented.

So with that, of course, we started out at the same place. close to the same place and then let's go through I'm going to just highlight assessments were down these are the \$75 a year people like me that aren't standby aren't hooked up we're just kind of contributing to the cause and that's fallen off significantly but all I did is budget for next year about the same we got this year.

Connection revenues and the related ID water gross receipt taxes kind of go together and the standby charges same thing with the standby gross receipts tax so we were a little low on connection revenues compared to the budget and a little high on standby however keep in mind that when I budget I have to

kind of have to look at the number of connections and all that stuff, and kind of figure out what's going to come in.

And of course, there's always timing differences. Some people pay ahead, some people pay in arrears. So this is, you're going to expect these kind of advances and something like that.

And it's basically no big deal. It's just, you're going to, people are, you can't control the exact timing of when people pay.

one of the, one of the advantages of using what we're using is cash accounting, because cash is what you got to manage.

If we want to full accrual accounting, then we can make adjustments for these timing differences and payments. But that, I don't think that would be as useful to you as just managing the cash.

So that's what leads to some of these timing differences. So, Always put in a little bit of money for I didn't put in any money for donations.

You got 25 bucks I decided that may be a Outlier, so I didn't put anything in the budget The only thing now that's going into interests and miscellaneous is interest So I just up that down to the 2024 roughly amount So that's the revenues so in total your revenues came out 1166 bucks shy of the budget but Not a huge deal.

It's just timing Accounting there has been a small increase and this is your Wicked, I think it is. Yeah, then there was a small price increase that I didn't catch So I just updated it to the 2004 the vast majority of her 2025 budget is based on what you spent in 2020

And that's because your operations are quite stable with one exception as repair maintenance but we'll get to that. So that I'm using mostly the 2024 actual.

Now the certified water operator Liz told me there's some additional charges that were associated with I guess having the certified water operator approved things like tank repairs and stuff like that that we've not been built for.

So that's why I upped the 2025 budget. Liz gave me an estimate of \$45 an hour and probably eight hours so I that's where the additional money came from for the certified water operator for 2025.

D&O insurance came out exact. Upped it a little bit, I think about 3% for inflation, because eventually it will go up.

Easement leases is flat, but that doesn't change. Electrical costs, again, I just adopted what you did in 2025. We were only 52 bucks off in 2024.

Liability and property went up, and so I I built in a small increase for 2025, so it went up in 2024.

And again, inflation tends to drive this stuff up a little each year. The growth receipts tax, that's tied to the revenue.

That's a pass through from the revenue. I always put in about 500 bucks in legal fees, even though you haven't spent anything in a couple of years, just in case.

being as pretty stable as you can see. The miscellaneous, we didn't have any, but again, to be a little conservative I'd build in \$150 every year just in case.

Now we get to the fun part. Operations and maintenance were over budget by \$7.18 and everybody knows why. You got the fire hydrant and the pump in there.

Now what I did, this gets a little bit more complicated for 2025. So what I did is I put it in a flat \$1,500 for kind of miscellaneous small and smaller maintenance and then working with Liz, I picked up, we're going to have to pay a second half to, is it Jeffries or whatever, on the installation.

of the fire hydrant, because we we've only paid half that bill. And then I threw in another \$1,500 for switching out the pipe, which we're just now getting down to estimates on.

So that one I have to kind of do a sophisticated wild- guess on. I also threw in some extra money for the pump that the booster pump that went out, because as Liz said, there's some parts that need to come in, etc.

But that again is kind of a guess. But I'm trying to capture in the budget what we're going to have to spend to close out those two projects in 2025.

So that's where this over the budget. Liz did a lot. their envelopes and letters and postage stamps and checks last year.

And I kind of backed down from what she spent my little bit because I didn't think that she's going to have to buy new checks any time soon because you don't write many of them.

So that's kind of where I came up with that budget. Water conservation fee is pretty flat. I don't know why it was \$3 short, but I just used, I went with the 2024 budgeted figure here just again to be a little conservative.

The cost of the website went up because Doug, you're using something called an email slash feature.

Yeah The loan payments are all we're almost all dead on when I did the budget We didn't know what the phase three loan the new loan would be so My budget was a little low For that payment, but I'm picking up last year's payment now from now on that will be flat So there's the main problem, of course is these magnets projects, and I built in enough Hopefully enough money to handle closing them out plus another \$1,500 for other stuff that might come up now Um None of this is a real crisis.

I did when we get now we got to get down to how much of this money you're going to transfer to reserves.

Because the 2015 budget from your operating budget is only going to be about 900, based on this budget obviously, is only going to be a positive 900 bucks.

And that money I said, okay, let's stop transferring reserves to capital and maintenance. Because the board has a general, we adopted a general policy when we started this process.

First of all, the money we've been transferring to the capital and maintenance reserve has been what we could scrape out of the checking account, the unreserved, without dropping it below \$20,000.

So the board said let's keep \$20,000 in unreserved, and then anything or that will just jump into reserves. And so since our budgeted

at the end of the year is a little bit below 20, I said let's just shut off the transfers to capital and maintenance.

And we don't need any more transfers to the loan reserve because the Ford adopted a policy who want one year's worth of payments in that loan reserve.

And we've got a little bit more than that. The loan reserve is \$12,500 and your total loan payments are a little over 11,000.

So we've got a little cushion there. So that's why you've only got one resolution this year and just adopt the budget.
